END-USER SOFTWARE LICENSE AGREEMENT

BY ACCESSING AND USING THE SOFTWARE, YOU AGREE TO BE BOUND BY THE TERMS OF THIS END-USER SOFTWARE LICENSE AGREEMENT. IF YOU DO NOT AGREE, DO NOT ACCESS, COPY, OR USE THE SOFTWARE.

THIS END USER SOFTWARE LICENSE AGREEMENT (this “Agreement”), is a binding legal agreement between you (whether you are an individual or an entity) and DataVis™.

1. ENTIRE AGREEMENT

This License constitutes the entire agreement between DataVis™ and you with respect to the Software (as hereinafter defined) and supersedes any and all communications, oral and written, between you and DataVis™ on this subject.

2. LICENSE

(a) License. DataVis™ hereby grants you a non-exclusive license to access and use solely for your own internal purposes the “Software,” as herein defined, and related documentation. Such license shall take effect upon your payment of the applicable license fee and shall continue in effect for a period of one (1) year (the “Term”). For purposes of this License, the term “Software” means the DataVis™ Platform, including its multiple sub systems or modules.

(b) Ownership. DataVis™ retains all ownership of intellectual property rights in the Software, subject only to the limited usage rights granted to you above. You may not rent, lease, lend or provide commercial hosting services with the Software. In addition, you may not reverse engineer, decompile, or disassemble the Software.

3. LIMITED WARRANTY; DISCLAIMERS

(a) Warranty. DataVis™ represents and warrants that the Software furnished hereunder shall be free from significant programming errors and from defects in workmanship and materials and shall operate and conform to the performance capabilities, specifications, functions and other descriptions and standards applicable thereto as set forth in the accompanying documentation. This limited warranty is void if failure of the Software has resulted from accident, abuse, misapplication, abnormal use or a virus introduced by you.

(b) DataVis™'s Fulfillment of Warranty Obligations. If, at any time while this Agreement remains in effect, DataVis™ or you shall discover one or more defects or errors in the Software or any other respect in which the Software fails to conform to the provisions of any warranty contained in this License, DataVis™, in its sole discretion, may (i) undertake such commercially reasonable efforts, as it deems appropriate, to correct such defect, error or non-conformity or (ii) refund to you an amount equal to the advance fees paid by you for the then unexpired portion of the Term.

(c) WARRANTY DISCLAIMER. EXCEPT FOR THE EXPRESS WARRANTIES SET FORTH IN THIS AGREEMENT, DataVis™ IS PROVIDING THE SOFTWARE AS IS AND DISCLAIMS ANY AND ALL OTHER WARRANTIES, WHETHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

(d) Exclusive Remedy. As set forth in Section 3(b), your exclusive remedy for any breach of the limited warranty set forth in Section 3(a) shall be limited to repair or replacement of the Software or the return of a portion of the advance fees paid by you, as determined by DataVis™ in its sole

discretion. Under no circumstances will DataVis™ be held liable for any data quality issues or decisions that are undertaken as a result of data in the DataVis™ system.

4. EXCLUSION OF DAMAGES; LIMITATION OF LIABILITY

TO THE MAXIMUM EXTENT PERMITTED UNDER APPLICABLE LAW, IN NO EVENT SHALL DATAVISTM BE LIABLE TO YOU FOR ANY SPECIAL, INCIDENTAL, INDIRECT, CONSEQUENTIAL, EXEMPLARY OR PUNITIVE DAMAGES, INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF REVENUES OR LOST OR ANTICIPATED PROFITS, ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT AND YOUR USE OF THE SOFTWARE, WHETHER OR NOT DataVis™ HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT SHALL DataVis™'S LIABILITY ARISING OUT OF OR IN CONNECTION WITH ITS LIMITED WARRANTY UNDER SECTION, WHETHER IN CONTRACT, TORT OR OTHERWISE, EXCEED THE AN AMOUNT EQUAL TO THE UNAMORTIZED PORTION OF ANY ADVANCE FEES ACTUALLY PAID BY YOU TO DataVis™ AS OF THE DATE THE CLAIM OF SUCH LIABILITY WAS MADE.

5.. MISCELLANEOUS

(a) Applicable Law. This License shall be governed by and construed in accordance with the laws of the Commonwealth of Massachusetts, without giving effect to any choice-of-law rules that may require the application of the laws of another jurisdiction. The parties agree that the exclusive jurisdiction (personal and, as allowed, subject matter) and venue for any action relating to this License shall be a federal or state court in Boston, Massachusetts, and the parties hereby consent to such jurisdiction and venue.

(b) Severability. Any invalidity, in whole or in part, of any provision of this License shall not affect the validity of any other of its provisions.

(c) Assignment. This License is personal to you and may not be assigned or sublicensed.
